## SIDEWALK AND TENT SALES

- 1. Sidewalk sales may utilize up to a 10'x10' canopy (without sides) for their sale as long as there is no electricity or cooking.
- 2. A sidewalk sale permit must be obtained from the Clerk's Office.
- 3. For tents larger than 10'x10' or with sides must first have written approval from the Chesterfield Township Fire Marshall.
- 4. A permit must then be obtained from the Building Department as well as an electrical permit if electricity is to be brought into the tent.
- 5. The Building Department application must also have a drawing showing where the tent will be placed on the property in relation to the building.
- 6. Costs of the building permit shall be \$65.00 with a \$300.00 bond; additional permit fees may apply for utilities.
- 7. Note: Cooking or serving food in or from the tent must have written approval from the Macomb County Health Department and the Chesterfield Township Fire Marshall.
